Dear Mrs. Monica Auer:

This letter is further to your request of October 15, 2020, to obtain:

“Please provide a list of the broadcasting and/or telecom 'Part 1 applications' that were received by the CRTC from 1 January 2016 to 30 September 2020 and which the CRTC did not post on its website. Thank you. ”

I am pleased to enclose the releasable documents relevant to your request, which are disclosed under the authority of the *Access to Information Act* (ATIA). You will note that certain records or portions thereof have been withheld under sections 20(1)(b), 21(1)(b) of the ATIA.

I have made all decisions concerning the disclosure of records relevant to your request, having received delegation to do so from the head of the institution. Furthermore, I decided both the issue of the applicability of exemptions and the issue of whether the information should, as a matter of discretion, nevertheless be released.

Please be advised that you are entitled to submit a complaint regarding the processing of this request to the Office of the Information Commissioner of Canada, 30 Victoria Street, Gatineau (Québec) K1A 1H3. The ATIA allows a complaint to be made within 60 days of the receipt of this notice.

financial, commercial, scientific or technical information that is confidential information supplied to a government institution by a third party and is treated consistently in a confidential manner by the third party;

21(1)(b) CONSULTATIONS OR DELIBERATIONS

an account of consultations or deliberations in which directors, officers or employees of a government institution, a minister of the Crown or the staff of a minister participate,
